ORDER

WHEREAS, ShriJagannath Sanskrit Vishvavidyalaya, Plot No.- 1441-1469, Vill.- Puri, P.O.- ShriVihar, Tehsil/Taluka- Puri, Town/City- Puri, Dist.- Puri, Odisha- 752003 (Code No. ERCAPP1305) was granted recognition for conducting B.Ed. courseof one year duration with an intake of 100from the academic session 2012-2013vide ERC's order No. ERC/7-139.6.9/NCTE/B.Ed./2012/13259 dated 13.08.2012.

- 2. **AND WHEREAS,** Revised Recognition Order (RRO) was issued for conducting ShikshaShastri- B.Ed. course of two years duration with an intake of 100 (two basic units) from the academic session 2015-2016 vide ERC's No. F. ERC/NCTE/ERCAPP1305/ShikshaShastri-B.Ed.(Revised Order)/2015/32703 dated 31.05.2015 as per NCTE Regulation, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. **AND WHEREAS,** a Public Notice was uploaded on ERC's website on 30.01.2018, wherein 138 TEIs have not furnished their compliance reports in respect of conditions mentioned in the Revised Recognition Orders issued on or before 31st May, 2015 on the basis of implementation of NCTE Regulations, 2014. The ERC in its 254th meeting held on 16th 17th April, 2018 considered the matter and decided, 1st Show Cause Notice was issued on 20.04.2018 to the institution on the following grounds:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.

b. Approved building plan by the concerned competent Govt. Engineer/Authority.

c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.

d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.

e. Confirmation on website updates of the institutions with all details along with affidavit.

4. **AND WHEREAS,** the institution has failed to submit reply of Show Cause Notice within the stipulated period of 21 days. The ERC in its 271st meeting held on 24th – 25th April, 2019 considered the matter and decided, Final Show Cause Notice was issued on 18.05.2019 to the institution on the grounds mentioned therein.

- 5. **AND WHEREAS,** the institution has failed to submit reply of Show Cause Notice within the stipulated period of 21 days. The ERC in its 278^{th} meeting held on $16^{th} 18^{th}$ January, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made:-
 - (i) Two show cause notices issued on 20.04.2018 & 18.05.2019 and no reply has been received till date.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

- 6. NOW THEREFORE, recognition granted to the institution viz. ShriJagannath Sanskrit Vishvavidyalaya, Plot No.- 1441-1469, Vill.- Puri, P.O.- ShriVihar, Tehsil/Taluka- Puri, Town/City- Puri, Dist.- Puri, Odisha- 752003 (Code No. ERCAPP1305) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session2020-2021.
- 7. **FURTHER,** if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
