Sir,

Please recall the discussion on GRAMSAT held on 19.09.2007 on Total sanitation Campaign (TSC). The importance of promoting the TSC was reiterated by the Hon'ble Chief Minister, Orissa in very emphatic terms.

It may not be out of place to mention that only 1875 G.Ps out of 6234 G.Ps has so far been covered under the TSC in the last 5 years. In order to increase the pace of the Campaign, Government has in principle agreed to provide incentives to Sarpanches, Rs.1,00,000/- for 1000 toilets. This incentive for toilet – built and used – will be available for a limited period only, beginning from 2nd October, 2007 to 1st April, 2008..

The details are given below:

1.	501 to 1000 IHLs	50,000
2.	1001 & above IHLs	1,00,000

1. The award money is a cash incentive to the individual Sarpanch towards social mobilization and motivation to beneficiaries for construction and use of toilets. The award money will be met from the IEC Fund of TSC available in the District. The incentive patterns will be based on number of installed & used household toilets both in BPL & APL households.
2. While involving PRIs, it is essential to create sufficient awareness and training and simultaneously ensure proper maintenance of records. For the purpose of awards/incentives, every Sarpanch would require to submit the application for incentive (enclosed) and also maintain a register indicating names of beneficiaries who have availed the facility.
3. You are requested to have a workshop on TSC at all Block levels on 2nd October, 2007 to provide necessary understanding of the Campaign to Sarpanchs of all GP's to promote the Campaign. The same forum may also be used to explain the Jaldhara unilater to the member of Panchayati Raj Institution.
4. As Chairperson of the District the Sanitation Committee, you have a very important role to play and Government hopes to achieve a sizeable target by 31st March, 2008. This is possible only with your active co-operation, which I am sure you will extend to these programmes.
5. As you are aware these incentives are in addition to GP being amended with Nirmal Gram Puraskar Award given by Ministry of Rural Development.
