ADVERTISEMENT FOR TEMPORARY ENGAGEMENT OF DRUGS INSPECTORS  
ON CONTRACTUAL BASIS.**

**The last date of receipt of application is 10<sup>th</sup> of September, 2007.**

Application with detail bio-data in plain paper as per proforma indicated below is invited for temporary engagement of Drugs Inspectors on contractual basis with a consolidated salary of Rs. 8,000/- per month up to 29.02.2008 or till receipt of recommendation from O.P.S.C for regular appointment, whichever is earlier.

**Eligibility-** A candidate must be a citizen of India & must not be below 21 years and over 32 years of age as on 01.08.2007. The upper age limit is relaxable in case of SC/ST and Ex-servicemen candidates up to five years and in case of S.E.B.C candidates up to three years. Provided that a person who comes under more than one category mentioned above, shall be eligible for only one benefit of upper age relaxation which shall be considered most beneficial to him/her.

**Educational qualification:** The candidate must possess a Degree in Pharmacy or Pharmaceutical Sciences or Medicine with specialization in Clinical Pharmacology or Microbiology from a University established in India by law.

**Language Qualification:** A candidate must have passed Oriya equivalent to M.E School standard examination conducted by the Board of Secondary Education, Orissa / by any other competent authority or must have studied Oriya as a language subject in the HSC examination conducted by any recognized Board /University.

**Physical fitness :** A candidate must be of good character , good physique and free from organic defects or bodily infirmity. No person who has any financial interest ( in the import , manufacture or sale of drugs and cosmetics ) shall be appointed as an Inspector under Drugs & Cosmetics Act, 1940.

**Certificate to be attached :** The candidate should note that they must attach true photo copies of the following certificates and documents duly attested by a Gazetted Officer .(i)H.S.C or equivalent examination certificate in support of date of birth.(ii)Certificate and mark lists of all examinations passed in support of academic qualification. (iii)Certificate of character , professional experience if any.(iv)Certificate in support of passing ME standard examination in Oriya.(v)Caste certificate in respect of S.C/S.T/S.E.B.C candidate issued by the competent authority .(vi)Certificate in support of Ex-Servicemen/Sports person, issued by the competent authority.(vii)Two Self addressed envelopes.(viii)Two recent passport size photographs duly signed by the candidate on its front out of which one should be pasted on the right hand corner of the application form.
