On the constitution of the State Farmers' Commission vide notification No.52/1 Ag. Dt.02.01.2010, the State Government do hereby determine the following fees, honorarium and allowances payable to the Chairman, member and Member- Convener, namely:-

**1.Honorarium-**

- (a) The Chairman shall be paid a consolidated honorarium of rupees thirty-five thousand per month.
- (b) The Members other than Member- Convener shall be paid a consolidated honorarium of rupees twenty-five thousand per month.


**2. Sitting fees-**The Chairman and members shall be paid sitting allowance of rupees five hundred per day on which the meeting takes place on the prior notice issued by the Member- Convener.

**3.Travelling Allowance-**

- (a) The Chairman and the members shall be paid a travelling allowance and Daily allowance as admissible to the officers of commissioner rank in the IAS while touring on duty on official business
- (b) The Chairman, and Members shall be entitled to travel by Air and class-II tier A.C in train while touring on duty in connection with official business, for which no prior permission from Govt. shall be required.

However, honorarium will not be paid to the member, Dr. Niranjan Panda and Member-convenor, Sri D.P. Ray of the Commission, since they are holding the post of Chairman, Western Orissa Development Council and V.C., OUAT respectively. However, facilities like TA/DA and sitting fees will be admissible to them.






