Sealed Tender on plain papers are invited by the undersigned for disposal of one Ambassador Car (Petrol) bearing No. OR-02-K-7888 on "an as is where is basis" condition of Excise Department.

- 2) The vehicle can be inspected parked near the Driver's Rest shed near Finance Department in the Secretariat premises during office hours on any working day.
- 3) The offer should be accompanied with E.M.D. Of Rs.2,000/-(Rupees two thousand)only in shape of Bank Draft drawn in favour of DDO-cum-Under Secretary to Government, Excise Department and be sent through Registered post/Courier or by personal delivery. The personal delivery shall be received in Diary Section, Excise Department against issue of proper receipt .The offer should reach the undersigned on or before 21.11.2009 till 3.00 pm. All offers shall be opened on the same day at 3.30 pm in the office chamber of the Additional Secretary to Government, Excise Department in presence of the Tenderer or their authorised representatives, if any.
- 4) The highest bidder whose bid is accepted shall deposit 25% of the offered amount on the spot immediately after the confirmation of sale is made in his favour. The balance 75% amount shall be deposited within 7 (seven) days. In case, the bidder fails to deposit the 75% of the amount within 7 (seven) days, his deposit including the EMD shall be forfeited.
- 5) The successful bidder shall also remove the vehicle from the Secretariat premises within 7 (seven) days from the date of deposit of the 75% of the amount. Failing which ground rent @ 1% of the bid amount per day shall be charged till the removal of the vehicle.
