NOTIFICATION

No. FE-I-8/2010 2875 /Ex., Bhubaneswar dated the 22.06.2010 In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Orissa is pleased to make the following rules further to amend the Orissa Excise Service (Method of Recruitment and Conditions of Service of Group-A Officers') Rules, 2002, namely:-

1. (1) These rules may be called the Orissa Excise Service (Method of Recruitment and Conditions of Service of Group-A Officers') Amendment Rules, 2010.

(2) They shall come into force on the date of their publication in the *Orissa Gazette*.

2. In the Orissa Excise Service (Method of Recruitment and Conditions of Service of Group-A Officers') Rules, 2002 in rule-4, for sub-rule (1), the following sub-rule shall be substituted, namely:-

“(1) Recruitment to the post of Superintendent of Excise in the service shall be made by the following methods, namely:—

a. 50% of the posts by promotion from among members of the Orissa Excise Service, Group-B consisting of Deputy Superintendent of Excise; and

b. remaining posts by deputation from Orissa Administrative Service (OAS)-I(JB):

Provided that in case of non-availability of suitable officers in the cadre of Orissa Excise Service, Group-‘B’ for promotion, the remaining vacancies shall be filled up by deputation from OAS-I (JB) Officers”.
