NOTIFICATION

In exercise of the powers conferred under sub-section (7) of Section 90 of the Bihar and Orissa Excise Act, 1915 (Bihar and Orissa Excise Act 2 of 1915) the Board of Revenue do hereby direct that Board's Notification No. 2807 dated 25.3.2008 issued under Rule 115-B of the Board's Excise Rules, 1965, shall be substituted by the following :-

"Excise Adhesive Label fee @ 0.30 (thirty) paise for each bottle of I.M.F.L., Beer and Country Spirit Pouch/Bottle shall be charged".
Affixing of Polyester based hologram E.A.L. on each bottle of I.M.F.L., Beer and C.S. shall be compulsory.

Non affixture of the said E.A.L. on I.M.F.L., Beer Bottles and C.S. Pet Bottles/Glass Bottles/pouches by any Company or the supplier will invite penalty of Rs. 50,000/- (Rupees fifty thousand) only.

Any retailer found selling IMFL, Beer or C.S without affixture of polyester based hologram EAL shall invite penalty upto Rs.50,000/- . The penalty of fine shall be in addition to other legal action as per law.

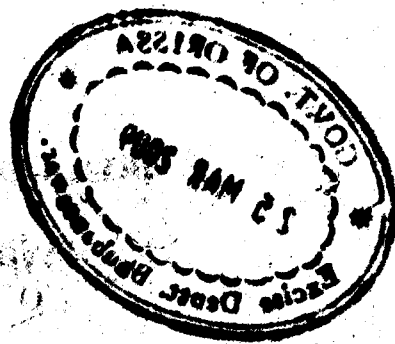
This amendment shall come into force with effect from 1.4.2009.
