- (b) Medical Certificate of fitness from a Govt. medical practitioner not below the rank of an Assistant Surgeon.
- (c) Attested copies (induplicate) of all Educational Certificates, Caste Certificates, Physically handicapped Certificate etc. claiming reservation. They should also bring with them the Original Certificates for verification at the time of joining.
- (d) Permanent address in full.
- (e) Oath of allegiance duly filled in.
