Applications are invited from intending candidates for appointment as President/ Member in the following Districts Consumer Disputes Redressal Fora of the State and member, State Consumer Disputes Redressal Commission, Orissa, Cuttack. The appointment shall be for a period of five years from date of joining or till the date the person completes 65 years of age, in case of President /Member of District Fora and 67 years of age in case of member State Commission whichever is earlier.

(2) **Qualification for the post of President:** The candidates must be a person who is, or has been or is qualified to be a District Judge in accordance with provision of Sub-Section 1(a) of Section 10 of the Consumer Protection Act 1986.

(3) **Qualification for the post of Member and Member (Woman)(District For a) and Member (State Commission):**

The candidates must have completed 35 years of age as on 01.1.2009, and must:

- (i) Possess a bachelor's degree from a recognized university, and
- (ii) Be person of ability, integrity and standing, and have adequate knowledge and experience of at least ten years in dealing with problems relating to economics, law, commerce, accountancy, industry, public affairs or administration.

(4) The applicant should not have incurred any disqualification mentioned in proviso to sub section (b) of section 10 of the Consumer Protection Act, 1986. Applicants are advised to carefully go through the provisions of the Consumer Protection Act, 1986 and satisfy themselves about their eligibility for being appointed as President/Member/Member State Commission, as the case may be.

(5) The applications in the prescribed format along with self addressed envelope with postage stamp for Rs.22/- should reach the Commissioner-Cum-Secretary to Government, Food, Supplies and Consumer Welfare Department, Bhubaneswar – 751 001 by 31.7.2009. The application should be accompanied by attested true copies of all testimonials and certificates in support of the qualification, experience and suitability and a duly sworn affidavit in the prescribed format. Candidates not affixing postage stamp shall be intimated about date of interview by a letter Under Certificate of Posting only.

(7) Candidates applying for posts in more than one District Forum also need to submit only one application form. However, they should indicate their order of preference for appointment in the Form.
