

**PROCEEDINGS OF THE MEETING OF HIGH POWER COMMITTEE
CONSTITUTED VIDE GOVERNMENT NOTIFICATION NO. 15641/HE DATED
01.05.2004 HELD ON 04.06.2009 AT 3 P.M. AND 05.06.2009 & 06.06.2009 AT 11.00
A.M. IN THE OFFICE CHAMBER OF COMMISSIONER-CUM-SECRETARY TO
GOVERNMENT, DEPARTMENT OF HIGHER EDUCATION**

1. The meeting of the High Power Committee constituted vide Government Notification No.15641/HE dated 01.05.2004 was held under the Chairmanship of Commissioner-cum-Secretary, Department of Higher Education in his office chamber to consider the proposals for grant of permission/recognition in respect of general/professional colleges under Section-5 and 6 of the Orissa Education Act, 1969. The Special Secretary to Government in Higher Education Department attended this Committee meeting as a Special invitee as per the desire of the Chairman.

The Commissioner-cum-Secretary to Government, Department of Higher Education and the Chairperson of the Committee while initiating discussion indicated that altogether 340 proposals for grant of permission/recognition in respect of General and Professional Colleges were placed before the committee for consideration. After detailed discussion following decisions were taken.

2. Opening of New +2/+3 Colleges:

All together 63 proposals were received from Regional Directors of Education in respect of +2/+3 Colleges. The Committee after detailed discussion decided to allow only 31 cases, 01 proposal was deferred and rest 31 cases were rejected. The list of cases allowed/deferred/rejected is placed at **Annexure-A**.

This opening permission is granted, subject to the condition that the educational agencies shall pledge an amount of Rs.5.00 lakhs in favour of the prescribed authority and further amount of Rs.20.00 lakhs shall be shown in shape of Bank deposit standing in the name of the college within a period of one month from the date of grant of permission, failing which the educational agency shall not be permitted to admit students. The condition cannot be relaxed by Director, Higher Education and Regional Directors of Education under any circumstance. Further Secretary of the Governing Body must furnish an undertaking in the form of an affidavit that they will not claim any financial assistance or grant-in-aid from Government in future.

The Regional Directors of Education are requested to put the following conditions strictly as per decision of High Power Committee Meeting dated 28.03.2007 in their permission letter to be issued to college concerned.

- i) That, the college should acquire required land (2 Acres in Urban area / 5 Acres in Rural area) in its name within the first two years failing which temporary recognition beyond two years shall not be granted.
- ii) That, the college shall start construction of required building (Class room, Laboratory, Library etc.) by 4th year and its progress should be verified while allowing temporary recognition. The progress of civil construction should be at least as follows:-

By 4th year – 25%

By 5th Year – 50%

By 6th Year – 75%

By 7th Year – 100%

3. Grant of Temporary Recognition to +2/+3 Colleges:

The Department had received 41 proposals for grant of temporary recognition in respect of +2 and +3 colleges. After detailed discussion the committee allowed 38 cases and rest 03 cases were deferred. The list of cases allowed/deferred is placed at **Annexure-B**.

4. **Grant of Permanent/Temporary Recognition to +2/+3 Colleges:**

The Department had received 7 proposals for grant of permanent recognition in respect of +2 and +3 colleges. After detailed discussion the committee allowed all 7 cases. The list of cases allowed is placed at **Annexure-C**.

5. **Increase of Seats:**

The Department had received 35 proposals for grant of permission to increase of seats in respect of +2 and +3 colleges. After detailed discussion the committee allowed 30 cases, 03 proposals were rejected and rest 02 proposals were deferred. The list of cases allowed/rejected/deferred is placed at **Annexure-D**.

6. **Opening of New Subjects:**

Proposal for opening of new subject in 53 (+2 and +3) colleges were received from Regional Directors of Education for consideration. After detailed discussion the committee allowed 42 cases, 03 proposals were deferred and rest 08 proposals were rejected. The list of cases allowed/deferred/rejected is placed at **Annexure-E**.

7. **Opening of Honours Subjects:**

All together 52 proposals for opening of Hons. subjects in +3 colleges were received from Regional Directors of Education for consideration. After detailed discussion held in this regard the committee decided to allow 48 cases, 01 case was deferred and rest 03 cases were rejected. The list of cases allowed/deferred/rejected is placed at **Annexure-F**.

8. **Opening of New Stream in +2/+3 Colleges:**

The Department had received 43 proposals for opening of new stream in respect of +2 and +3 colleges. The committee after discussion allowed only 03 cases, 02 cases were rejected and rest 38 cases were deferred due to shortage of time. The list of cases allowed/rejected is placed at **Annexure-G**.

9. **Professional Colleges:**

Altogether 54 proposals were received from Director, Higher Education in respect of Private Professional Colleges. Out of 54 proposals, 36 proposals are relating to opening permission & increase of seats and rest 18 proposals are relating to temporary & permanent recognition. After detailed discussion the committee decided to allow 23 cases, 12 cases were rejected and 01 case was deferred in respect of

opening permission & increase of seats. The list of cases allowed/rejected/deferred in respect of opening permission and increase of seats is placed at **Annexure-H**. Similarly the committee decided to allow 14 cases and 04 cases were deferred in respect of temporary & permanent recognition. The list of cases allowed/deferred in respect of temporary & permanent recognition is placed at **Annexure-I**.

This opening permission is granted, subject to the condition that the educational agencies shall pledge an amount of Rs.10.00 lakhs in favour of the prescribed authority and further amount of Rs.30.00 lakhs shall be shown in shape of Bank deposit standing in the name of the college within a period of one month from the date of grant of permission, failing which the educational agency shall not be permitted to admit students. The condition cannot be relaxed by Director, Higher Education under any circumstance. Further Secretary of the Governing Body must furnish an undertaking in the form of an affidavit that they will not claim any financial assistance or grant-in-aid from Government in future.

The Director, Higher Education is requested to put the following conditions strictly as per decision of High Power Committee Meeting dated 28.03.2007 in their permission letter to be issued to college concerned.

- i) That, the college should acquire required land (2 Acres in Urban area / 5 Acres in Rural area) in its name within the first two years failing which temporary recognition beyond two years shall not be granted.
- ii) That, the college shall start construction of required building (Class room, Laboratory, Library etc.) by 4th year and its progress should be verified while allowing temporary recognition. The progress of civil construction should be at least as follows:-

By 4th year – 25%
 By 5th Year – 50%
 By 6th Year – 75%
 By 7th Year – 100%

10. Grant of Permission and Recognition to Sanskrit Colleges:

All together 04 cases in respect of Sanskrit Colleges were discussed by the Committee. After detailed discussion, the committee allowed 03 cases and 01 proposal was rejected. The list of cases which are allowed/rejected is placed at **Annexure-J**.

11. General Observation:

The following four general observations (Sl. ix to Sl. xii) are made by the committee in addition to the eight general observations already made in the meeting of HPC held on 13.05.2009 & 14.05.2009 (Sl. i to Sl. viii).

- i) Proposals for increase of seats can only be considered after appearance of at least one batch of students.
- ii) Any new teacher/non-teaching staff required for managing/teaching the students on account of increase of seats be funded out of self financing route. The honorarium/remuneration of these teachers should be at par with other teachers in the college. The college management should give an undertaking and affidavit before taking in new students. The H.P.C. observed that this should be followed strictly in view of the restrictions placed by the Finance Department on account of new appointments.
- iii) The qualification of I.T. lecturers and Computer Science lecturers shall be MCA and B.E. in I.T. or B.E. in Computer Science or MSc (Comp. Science).
- iv) Regarding grant of Temporary Recognition (TR) for back periods, HPC had earlier decided to keep the period as such. This is creating problem for the institutions regarding continuity in Recognition. Therefore, the HPC felt it necessary to reverse the earlier decision and allow TR for back periods.
- v) The college/institution has to produce a certificate from Tahasildar regarding location of land and building owned by the college authority for Permanent recognition.
- vi) Permanent recognition would be given in 2-3 years i.e. after passing of one batch of students, if the college fulfills all the necessary conditions as provided in the Orissa Education Act, 1969.
- vii) Any permission for opening of new colleges, increase of seats, opening of new stream, opening of new subject and opening of Hons. subjects will be considered by the month of May every year. Similarly for of grant of recognition (temporary/ permanent), the colleges/institutions have to apply by the end of August of every year which is to be considered in the month of September/October. Thus there would be two phase of HPCs in a year, one for Opening Permission and second for grant of Recognition.

- viii) Five subjects is to be allowed for +3 college having 64 seats instead of 4 subjects.
- ix) For opening of new subjects/new streams due to restrictions by Finance Department, no new faculty can be recruited by the management. They can run it under self-financing mode like I.T. or Computer Science only. If any college is willing to abide by this condition, it can open a new subject/new stream.
- x) Sanskrit as an 'Elective' subject in +2 Science seems to have been included in 2007 vide notification No. 14019/HE dt. 01.03.2007. As the matter is under reconsideration of Government, all matters relating to any college opting for 'Sanskrit' as an Elective subject under +2 Science stream is to be deferred till a decision in the matter is taken by the Government.
- xi) Separation of laboratory between Junior and Degree College is necessary. Similarly improvement of Science laboratory for opening of Honours subject is essential and has to be certified before grant of FTR for any new Honours subject.
- xii) At present, there are 35 Self-Financing +2 Science Junior Colleges functioning in the Municipal limits of Bhubaneswar. It was reported that there are applications for starting 25 more +2 (Junior) Residential Science Colleges in and around Bhubaneswar. As there are a large no. of vacant seats in existing Residential Colleges and as starting of 25 new Colleges would require a large number of trained teachers/Lecturers, the committee felt that giving opening permission to such large number of Junior Science Colleges would not be in interest of education. Secondly, there seems to be no felt need to start so many new Junior Colleges in the Capital City when feeder High Schools are limited.
