2. The Committee will meet as and when necessary to review the situation arising out of Natural Calamities. The Board of Revenue (Special Relief) will furnish periodical reports for the consideration of the Committee.

3. The function of the Committee shall be :-

- a) To advise the Government regarding precautionary measures to be taken in respect of flood, drought and other natural calamities.
- b) To assess the situation arising out of such calamities.
- c) To recommend to Government the nature and quantum of relief; and
- d) To recommend to Government the policy to be adopted in giving such relief in areas affected by such calamities.

4 Members of the Legislative Assembly, who attend the meetings of this Committee are entitled to get T.A and D.A as admissible to them under the Orissa Legislative Assembly Member's Salaries and Allowances Act and Rules issued thereunder in accordance with Finance Department Resolution No.7635/F., dt. 4th March, 1972, as amended from time to time.
