Sub: Amendment of the Orissa Circuit House & Inspection Bungalows Rules-1985 & Revision of Tariff of Special Circuit House / Circuit House and Inspection Bungalows of the State regarding.

In partial modification of Revenue Department Resolution No.60985/R dtd.15.10.1985 and Resolution No.8867/R dt.03.03.2004 the room rent and user charges of Special Circuit House / Circuit House / Inspection Bungalow / Revenue Rest Sheds shall be revised as below:

This order comes into force with effect from 1.6.2008


The other provisions of Orissa Circuit House and I.Bs Rules, 1985 shall remain unaltered.
