RESOLUTION

No. 45419/R&DM Bhubaneswar dated the 25th October, 2008
S-25/2005

In order to ensure timely coordination between the district administration of Kandhamal district and the State Government and with an objective to bring about over all improvement of governance in developmental administration, a post of Special Administrator, Kandhamal district has been created.

2. The functions and the responsibilities of the Special Administrator will be as follows, with reference to Kandhamal district:

- i) He will oversee the implementation of the special package for Kandhamal district announced by the State Government in close coordination with the Departments concerned.
- ii) He will particularly give emphasis on verification of Caste Certificates and the follow up actions.
- iii) He will review qualitative and quantitative implementation of poverty reduction programmes of all departments.
- iv) He will particularly supervise and monitor implementation of the following programmes:
 - a. NREGS
 - b. Public Distribution System.
 - c. Madhubabu Pension Yojana and other social welfare schemes.
 - d. Primary health care including mobile health units.
 - e. Indira Awas Yojana.
 - f. Relief and Rehabilitation measures of communal/ethnic violence in Kandhamal district.
 - g. Developmental programmes of Integrated Tribal Development Agencies.
 - h. Primary School Education Programme including hostels/schools under the administrative control of ST and SC Development Department.
 - i. Orissa Tribal Empowerment and Livelihood Programme.
 - j. Watershed Development Programme.
 - k. Self-employment Programmes including Prime Minister's Rojagar Yojana and SGSY.
 - l. Rehabilitation of bonded labour.
 - m. Administrative review of progress under Regulation 2 of 1956.
 - n. Administrative review of implementation of Orissa Money Lenders' Act.
 - o. Administrative review of progress of verification of allegedly fraudulent caste certificates.
 - p. Review of price structure for minor forest produce, fixed by the concerned Panchayati Raj Institutions.
 - q. Measures for value addition of minor forest produce.

- r. Marketing of spices and other organic agricultural products.
- s. Any other scheme, which may be specifically entrusted to him by the Government from time to time.

3. The Special Administrator has been delegated with the powers under Section-6-D, 15 and 25 of Orissa Survey and Settlement Act, 1958 (Orissa Act 3 of 1959) in respect of Kandhamal District for quick disposal of the revision cases vide Revenue & D.M. Department Notification No.43586/R & D.M., dated 13.10.2008.

4. Special Administrator will be responsible for collection of information about expenditure and physical achievements under the programmes listed. He will also furnish necessary reports and returns to the concerned administrative departments.

5. Special Administrator would make available copies of his tour note to the departments concerned. He may suggest any proposals for rationalization, modification and improvement of guidelines or procedure prescribed by the State Government for implementation of any development programme under the Government. He will refer such proposals to the administrative department concerned for decision of the Government.

6. The Special Administrator is vested with the following administrative powers.

- ii. He may inspect or caused to be inspected any office at the district or sub-ordinate level in the project area concerned with the programmes, projects and schemes listed above, so far as implementation of these programmes is concerned.
- iii. He may record remarks in the CCR of any officer upto the rank of Head of Department who is concerned with the implementation of the programmes if he considers it so necessary and forward the same to the Reviewing Authority which would be treated as the remarks of the second countersigning officer.
- iv. He shall have power to conduct or cause to be conduct such enquiries into the matters as are referred to him or as otherwise come to his notice. The findings of enquiry shall be made available to the Department concerned for appropriate action. He shall be provided with access to Government records relevant for the purpose of conducting enquiries.

7. The Administrator, Kandhamal district will have the financial powers of a Head of Department, as per the powers delegated under the OGFR.

8. The Administrator will maintain effective and close coordination with Secretaries of concerned departments of the Government. Any specific proposal made by the Special Administrator will be responded to by the Secretaries of the administrative departments within 48 hours.
