
Sub: *Revision of Pension / Family Pension of Pre-2006 Pensioners / Family Pensioners in case of employees of Primary Schools and Non Government Aided Educational Institutions.*

Sir,

I am directed to say that decision of Government for revision of Pension / Family Pension of Pre-2006 Pensioners / Family Pensioners who were employees of Primary Schools and Non Government Aided Educational Institutions was communicated in S&ME Department Resolution No.9708 dtd. 19.06.2009. But there was no mention in the said Resolution regarding payment of arrear to the above category of pensioners.

Now, it is decided that 40% of the arrear Pension / Family Pension shall be paid in the year 2009-10 and matters relating to payment of remaining 60% of arrear pension will be decided later. However, they will receive the current pension / family pension in the revised rate from June, 2009.


