
Pursuant to the orders of Hon'ble High Court passed in CONTC No.1126/2006 arising out of WP(C) No.8769/2005 directing the opposite parties to implement the order of Hon'ble SET in GIA case No.152/2004 filed by Managing Committee of Radhanath Bidyapitha, Arei under Puri Circle, the State Govt. in School & Mass Education Department as per Clause (b) of Section 3 of the Orissa Education Act, 1969 read with Paragraph 3,4 & 5 of the Orissa Education (Payment of grant-in-aid to High Schools, Upper Primary Schools etc.) order 2004 and subsequent amendment orders thereof, do hereby re-notify Radhanath Bidyapitha, Arei, Po-Desthali, Nayahat, Dist-Puri appearing at Sl. 
