OFFICE ORDER

In pursuance of Finance Department Circular No.40545(255) dt.29.08.2009, the monthly consolidated remuneration of the teaching staff (contract teachers) of Govt. High Schools of this Department engaged / to be engaged as contract basis in lieu of abolition of regular posts, shall be revised as under, but the grade pay attached to the revised scale of pay shall not count towards remuneration of contractual employees. :-

The contract teachers such as TGT/ Sanskrit/ Hindi/ Urdu/ Persian/ Telgu/TI/TM & PET whose posts are created on contractual basis by abolition of regular scale bearing posts shall be allowed to draw the revised monthly consolidated remuneration as at column-3 against their existing corresponding consolidated remuneration at column-2.
3. This revision shall come into force from the date of issue of the orders by Finance Deptt. i.e. w.e.f. 01.09.2009.
4. The Director, Secondary Education shall ensure proper implementation of the above order.
