

Payment of Block Grant to P.P. Tileswar High School Purunapani, Mayurbhanj (one G.P. one High School) coming under the category of sub-Para (4) of Para 3 of the Orissa Education (Payment of Grant-in aid to High Schools, Upper Primary Schools etc) order 2004 notified by the Govt. in School & Mass Education Department Notification No.3325 dated the 20th February 2004 was under active consideration of Govt. After careful consideration, the Govt. in School and Mass Education Department have decided that the Notification in respect the said High School appearing at Sl.No. 983 of the said Notification shall be treated as cancelled and in pursuance of clause (b) of section 3 of the Orissa Education Act 1969 read with sub-Para (a) Para 6 of the Orissa education (Payment of Grant in Aid to High School, Upper Primary Schools etc) Amendment order 2007, the State Govt. do hereby re-notify P.P. Tileswar High School to receive grant-in-Aid (Block Grant) w.e.f. 22.09.2007.

The Director, Secondary Education Orissa before release of actual Block grant shall conduct detailed scrutiny to find out as to whether the High School(One G.P. one High School) notified herewith confirms to sub-para (4) of Para-3 of the Orissa Education (payment of Grant-in-Aid to High Schools, Upper Primary Schools etc) order 2004 as amended vide sub- Para(a) of Para-6 of Orissa Education(Payment of Grant-in-Aid to High Schools, Upper Primary Schools etc) Amendment Order,2007.




